## Rules

Fairest of the Fair is a local county fair pageant providing an opportunity for young ladies to develop their skills in talent, stage presence, public speaking, and community service.

Young ladies may only win an age division one time.

**PAYNE COUNTY RESIDENTS ONLY, LIMITED TO TWELVE (12) ENTRIES PER DIVISION**  
Orientation is mandatory and is scheduled for Saturday, August 3, 2024. Orientation times will be specified in a letter, which will be sent to you acknowledging receipt of your application.

## TALENT

May include song, dance, poetry reading, humor, cheerleading, drama, monologue, or musical instruments. The contestants provide instruments and accompaniment You may have one person help with props. All talent performances must not exceed three minutes. Garments for Talent must be age appropriate.

## STAGE PRESENCE

All outfits should be appropriate for the age of the contestant. Attire should have a proper fit and should compliment the contestant and her personality. A pattern of X will be onstage in a T Formation. The contestant's biography will be read out loud during the modeling. If you have questions on wardrobe, please call or email the director (see information below).

## ONSTAGE INTERVIEW

All contestants will introduce themselves and draw an age appropriate question in the blind drawing. Garments worn during the Stage Presence competition will also be worn during the Question and Awards presentation ceremony.
