



# **GENERAL RULES AND REGULATIONS**

Eligibility is limited to 4-H and FFA members who participate in their respective organizations and must be residents of Payne County or attending school in Payne County and have not graduated high school. To participate in Payne County youth events, 4-H and FFA members must be "members in good standing" with their respective organizations. Members must be listed on their respective rosters and dues/fees paid to their respective organizations no later than December 1, 2025, to be considered a "member in good standing" and be able to participate in the 2026 Payne County Junior Livestock Show representing either Payne County 4-H or their FFA chapter. Students who transfer to a school in Payne County after December 1 and were a "member in good standing" in previous school/county, are eligible to exhibit. 4-Her's must also attend a minimum of 3 meetings of their primary Payne County 4-H Club and must be in 3<sup>rd</sup> grade and 8 years or 9 years old, regardless of grade, the day they walk into the show ring. Students must meet the academic eligibility requirements of their school as of the first day of the show. If a student is ineligible, his/her livestock entries are also ineligible.

1. <u>Prospect & Market Steers</u>: Exhibitors must have had continuous ownership of and personally fed and cared for daily. Market steers weighing 1001 lbs. or more and prospect steers 1000 lbs. or less by the due date of county nominations/entry.

<u>Beef & Dairy Heifers</u>: Exhibitors must have continuous ownership of animal and personally fed and cared for daily. **Beef Heifers 45 days** prior to show. Dairy heifers 75 days.

Market Swine & Breeding Gilts: Exhibitors must have had continuous ownership of animals and personally fed and cared for daily, market swine & breeding gilts by the due date of county nominations/entry. Swine nominations/entry are due 3 working days after OYE nomination due date, which is December 3, 2025.

Payne County Swine nominations are due December 8, 2025.

Swine exhibitors must have all gilts by nomination/entry and pedigree registration sale date and must be prior to the nomination/entry date.

Market Lambs & Breeding Ewes: Exhibitors must have had continuous ownership of breeding ewes and market lambs and personally fed and cared for daily. Market Lambs & Breeding Ewes by due date of county nominations/entry. Market lambs and Breeding Ewes will be nominated/entry 3 working days after OYE nominations.

<u>Market Goats & Breeding Does</u>: Exhibitors must have had continuous ownership of breeding does and market goats and personally fed and cared for daily. Market Goats & Breeding Does by the due date of county nominations/entry. <u>Market Goats and Breeding Does will be nominated/entry 3 working days after OYE nominations.</u>

Family nominations need to specify which exhibitor will show what animal at the official weigh-in or check-in (commercial females) of the show if not clarified what exhibitor shows what animal, then it will automatically go to the first name on the form, for those who family nominated. Members attending school in Payne County and living in an adjoining county or living in Payne County and attending school in an adjoining county can exhibit in only one county's fair and shows. The location of where animals are kept must be provided to Extension Agents and Ag Education Instructors for project visitation. Due dates for county nominations/entries will be sent out to Ag Teachers and The Payne County Extension Office to send out to all exhibitors

2. Each exhibitor will furnish own bedding and be responsible for his or her own animals. Wood shavings are required for swine, sheep and goat pens. Pens must be bedded prior to putting the animals in them.

#### DIVISION OF CLASSES 3.

#### Sheep

Sheep superintendents reserve the right to divide classes by weight or by numbers when there are six or more animals per breed. If there are 18 or more per breed, there may be 3 classes. If there are 41 or more per breed, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.

#### Swine

For Swine **Barrows**, the **eight** pure breeds to be recognized as a breed they must have at least 4 in that breed to be shown. If not, those animals will be shown in AOB class. As long as there are at least 4 head in the AOB class, the champion will sell in the Premium Sale. If AOB class doesn't meet classifications to make a breed, then AOB will fall under Class 1 of Crossbreds as Class 1 AOB/Cross. For Swine Gilts, all nine purebred breeds will be allowed to be

shown as their registered breed.

Swine superintendents reserve the right to divide classes by weight, or by numbers when there are six or more animals per breed. If there are 18 or more per breed, there may be 3 classes. If there are 41 or more per breed, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.

#### Steers

The prospect and market steer show will be conducted separately. Beef superintendents reserve the right to divide breed classes in the prospect and market steer show by weight, or by numbers into two classes when there are 8 or more. If there are 18 or more steers of one breed, there may be 3 classes. If there are 41 or more, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.

**Goats** Goat superintendents reserve the right to divide classes as they deem necessary.

# **SHOWMANSHIP**

4. For Beef Cattle, Dairy, Swine, Sheep, and Goat exhibitors, the divisions will be by grade as of show day as follows:

JUNIOR Grades 3<sup>rd</sup>-6<sup>th</sup>
INTERMEDIATE Grades 7<sup>th</sup>-9<sup>th</sup>
SENIOR Grades 10<sup>th</sup>-12<sup>th</sup>

- 5. Each exhibitor is permitted to show not more than 3 market barrows and show no more than 3 gilts total. 3 market lambs, (wethers or ewes), 3 market goats wethers and 3 does, show no more than 3 steers, (combo of market and prospect steers). Heifer show (beef and dairy) and breeding ewes 2 per class. Exhibitor must show his/her own animal, except in case of injury or illness (to be approved by department superintendent). All exhibitors must abide by posted stall assignments provided by Payne County Fairboard. All stall assignments are posted on the north side of the main office window.
- 6. Any exhibitor or resident of Payne County who has a protest regarding exhibits or exhibitors in the Jr. Livestock Show must file a written protest and \$50 to the Payne County Fair Board before action is taken. The protest must be filed no later than one hour after the conclusion of the beef show.
- 7. Entries must not be removed before the close of the show except by consent of the superintendent.
- 8. All animals must be free of any infections or communicable or contagious diseases. If any such disease is found, it will cause removal from grounds.

- 9. Parents and/or grooms will refrain from grooming animals as they enter the show ring. Superintendents will prohibit parents and groom from the show ring entrance.
- 10. For sheep and dairy there will be a breed show for each breed listed in the book regardless of the number of animals entered. For beef breeding cattle, there must be four (4) or more heifers of a breed owned by two or more exhibitors to have a breed show, otherwise they will go in AOB. All Brahman influenced and Longhorn cattle without the four head needed to make a breed will be grouped together in an American Breed Class. If those numbers for the American Breed Class don't meet the 4 head requirement, then those cattle will go into the AOB Class.
  - 11. The same breed percentages for beef heifers used in OYE will be used by Payne County Spring Livestock Show. All beef and dairy heifers nominated/shown in the commercial, grade, or grade-up class at the spring livestock show will have to be shown as a commercial grade or grade-up heifer in the county fair, once a heifer is shown as a commercial grade or grade-up, she cannot then be shown as a registered purebred, neither shall heifers that have been exhibited in Payne County in any of the registered purebred classes later change and show in a commercial, grade, or grade-up class.
  - 12. Area traffic/parking signs are always to be observed.
  - 13. Designated fire lanes must be kept clear. Vehicles parked in unauthorized areas will be towed away and subject to recovery of the towing fee from the owner. The use of an electric, open flame or space heater is prohibited.
  - 14. Any person or persons not abiding by these rules and regulations may be subject to disqualification from this and future county shows. Premium money from the show and/or premium sales bonuses will be forfeited.

15. The right is reserved by the Payne County Free Fair Association to interpret, revise, or add to the rules as its interest may require.

#### Oklahoma 4-H & FFA Show-Ring Code of Ethics The Payne County Fair Board has adopted the following:

#### **4-H Member**: An exhibitor must wear

- An official 4-H clothing of the appropriate colors of solid green, solid white, or a mix of green and white.
- Must have an official 4-H emblem of at least 2½ inches that is permanently affixed to the front and left side of the vest or jacket.
- Exhibitor must wear a buttoned up collared shirt or polo shirt, short or long sleeves under the vest or either jacket that is the appropriate colors of solid green, solid white, or a mix of green and white.
  - If you have questions or need an official 4-H patch, please contact The Payne County Extension Office 405.747.8320.

#### FFA Member: An exhibitor must wear

- An official Oklahoma FFA corduroy jacket, pullover wind jacket, softshell jacket, sweater or vest.
- A pullover wind jacket, softshell jacket or vest must be of the appropriate colors of solid blue, solid yellow, or a mix of blue and yellow.
- Must have an official FFA emblem of at least 2½ inches permanently affixed to the front and left side of the jacket options or vest.
- Must wear a collared shirt under any of the jacket options or vest that is of the appropriate colors of solid white, solid blue, solid yellow, or a mix of blue and yellow.
- A buttoned up, collared shirt or polo shirt, short or long sleeve, of the appropriate FFA colors of solid white, solid blue, solid yellow, or a mix of blue and yellow.
- No third color mix or additional colors are allowed.
- Must have an official FFA emblem of at least 2½ inches that is permanently affixed to the front left side of the shirt

- 16. The exhibitor must be the sole owner of any animals shown in his/her name. Junior exhibitors must have owned, cared for daily and fed market animals from no later than the date nominated, or date listed in premium list of show. All other animals, including dairy animals, must be owned by, or transferred to the exhibitor by the required date listed in the show premium list.
- 17. In breeding classes, beef and dairy entries must be registered and recorded in the sole name of the exhibitor. Tattoos, brands, or registry association tags and flock tags must match the papers and be correctly located. Swine ear notches must be correct and healed; market hogs shown as purebred and must have healed ear notches in both ears.
- 18. All exhibitors are expected to provide the primary care and grooming of their animals throughout the show. An exhibitor may be assisted in grooming his/her animal. However, the exhibitor must be present and applying the level of expertise appropriate for that exhibitor's level of experience as deemed by his/her Ag Ed Instructor or county 4-H Agent. Therefore, beginning showmen are allowed more assistance than seasoned showmen.
- 19. The 2026 Junior Livestock Beef Show will be blow and show. The use of paint, glue, foam, or other adhesives and boning products of any kind will not be permitted. Boning of legs, alteration, or enhancement of color will not be allowed. Water, light oils, or sheen type products will be allowed. In short, if you question whether or not a product is allowed, do not use it. No aerosol cans, spray bottles, or styling products other than combs will be allowed past the checking area. Any cattle found in violation will not be allowed in the show ring and will be disqualified from the competition and award premium opportunities. All beef superintendents' decisions will be FINAL!

- 20. Any junior exhibitor entering livestock in competition must be present to lead and show said animal in competition, or the animal will be disqualified, and all premiums are voided. Any infraction of rules will cause forfeiture of any premiums earned. The only exceptions to this rule are where a bona fide owner has more than one animal in a given class and, due to an extreme emergency, the bona fide owner is not able to be in attendance. Such cases must be approved by management. Each animal offered for sale must be handled in the ring by the bona fide owner.
- 21. Soft muzzles will be allowed on sheep.
- 22. Treating or massaging any part of the body internally or externally with an irritant or other substance to temporarily straighten a weak back or loin; to produce unnatural, animation or to cause swelling or changes in contour or handling qualities is prohibited.
- 23. Minimizing the effects of crampiness or to affect handling qualities or contour by feeding or injecting drugs, depressants or applying packs (hot or cold) or using any artificial contrivance or therapeutic treatment except normal exercise is prohibited.
- 24. Striking the animal to cause swelling is prohibited.
- 25. Surgery or any other procedure performed to change the natural process of growth, maturation, contour, or appearance of any animal, to include teeth, is prohibited. Not included are removals of teats or horns, clipping and dressing of hair and trimming of hooves.

- 26. Injection or insertion of foreign materials under the skin or into the muscle is prohibited.
- 27. The use of alcoholic beverages in the feed or as a drench is prohibited.
- 28. Forced filling of any type by any means to include stomach pumps is prohibited. Rehydration of lambs will be allowed as needed.
- 29. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show.

In swine, no powdering, oiling, painting, or dressing other than water will be permitted.

In sheep, no paint, belly wool, or live fungus is allowed.

In goat, no glue products will be allowed in the fitting of goats, but powder is allowed. Blow and Show ONLY.

NO ADHESIVES ALTERATION ALLOWED ON ANY SPECIES.

30. The use of any chemical and/or compound that is not approved by the Food and Drug Administration for use in meat producing animals and the illegal use of approved chemicals and/or compounds is prohibited. All animals shall be subject to test (blood, urine, and tissue) for foreign substances that exceed the acceptable levels established by the United States Department of Agriculture and/or the Food and Drug Administration. A positive test will result in disqualification, forfeiture of any premiums and/or awards, and will exclude the exhibitor, organized group, or individual involved from future competitions at this show. All

medications at the show will be administered by licensed veterinarians only.

- 31. Balancing the udder by any abnormal means including the use of a mechanical contrivance or the injection of fluid or drugs, setting the teats and/or occluding (sealing the ends) with a mechanical contrivance or with the use of a chemical preparation, treating or massaging the udder or its attachments with an irritant or counterirritant will not be permitted. The use of common products such as fly spray, ointment, or liniment in excess to the extent that it is irritating is included as an irritant.
- 32. Criticizing or interfering with the judge, other exhibitors, breed representatives or show officials before, during or after the event may result in an individual or group being expelled, placed on probation, declared ineligible, or barred from exhibiting at the event.
- 33. Exhibitors, organized groups, or any individual switching animals at any time and/or changing ear tags and other forms of identification will be barred from showing and will forfeit all prizes and premium money.
- 34. Junior exhibitors, and adults involved with the exhibitors, are expected to adhere to the General Rules and Regulation of the junior livestock show including the Show-Ring Code of Ethics as well as the Rules and Regulations governing the Junior Division.
- 35. Any violation of the Rules and Regulations incorporated in this book may result in forfeiture of all premiums and awards, disqualification and expulsion or probation of the exhibitor, organized group the exhibitor represents, and/or any individual or livestock involved. Probation, disqualification, expulsion, or other disciplinary action of the show management will be final.

Such action will require application for readmission under such terms as the management may prescribe before the group or individual is allowed to exhibit at future events. Violations of rules at a show that is a member of show support organizations including the Oklahoma Association of Fairs and Festivals, the American Livestock Show and Rodeo Managers Association, and the International Association of Fairs and Expositions, may affect the eligibility of the violators for participation in any show throughout the country, regardless of the show's membership in these organizations.

- 36. Final interpretation of the following rules will be made by show management. Management decisions are final.
- 37. Any parents, participating adults or students' interference, misconduct, outburst, or inappropriate language, during the show that is a bad example will not be tolerated. The result of these actions can be your child or exhibitor being put on probation or excluded from ever showing here again and your removal from the facilities/grounds. We are examples for our children and youth at these shows. If you have a question or problem about or during the show, please conduct yourself in a correct and calm manner to a superintendent or fairboard member.

After each species program is posted (with the posting time indicated on the program), exhibitors will have one (1) hour to review and request any necessary changes. Once the one-hour period has passed, the program will be considered final, and no further changes will be accepted.

# PREMIUM AUCTION RULES

- 1. The premium auction will be at 7:00 p.m., Thursday, February 26, at the Payne County Expo Center, McVey Arena.
- 2. The number of animals in the Premium Auction will be:
  - ♦ 13 Market Steers
  - ♦ 16 Beef Heifers
  - ◆ 15 **Goats** (4 does and 11 wethers)
  - ◆ 37 Market Hogs
     (including all the market barrow breed champions)
  - ♦ 3 Purebred Gilts
  - ♦ 3 Crossbred/AOB Gilts
  - ◆ 31 Lambs (including all the breed champions)
  - 2 Breeding Ewes
     (1-champion commercial ewe & 1-champion purebred ewe)
  - ♦ 3 **Dairy Heifers** (top 3 based on quality)
  - ♦ 1 Prospect Steer
  - ♦ 1 Trio of Broilers sells per each 10 exhibitors

(Ex: 18 exhibitors, 1 pen will sell, 23 exhibitors, 2 pens will sell)

- 3. Only one entry per exhibitor is allowed in the Premium Auction.
- 4. Grand & Res Grand Champion must sell unless exhibitor has multiple grands and reserve grand champions. The exhibitor must sell the highest-ranking entry per sale category. In the event an exhibitor has animals in multiple sale categories for the Premium Auction, he or she must indicate to the sale committee which animal is to be sold within one hour after conclusion of the cattle show.
- 5. Each exhibitor having an animal in the sale will be assessed \$50 to cover the cost of the Buyer's Dinner. This fee will be deducted from the exhibitors' add-on contributions.

- 6. The sale order will be arranged by the Sale Committee.
- 7. No animal can be sold more than one time in its lifetime in the Premium Auction.
- 8. The judge will rank the beef and dairy heifers by quality and will continue to rank the remaining heifers by quality until all slots are filled, and alternates are selected.
- 9. A percentage of each breed of swine will sell based on the number of animals entered in the breed divided by the total number of swine in the show. In addition, the order that swine breeds will sell shall be determined by the judge after the Grand Drive. If an exhibitor has more than one swine selected for the sale, they will sell the original highest-ranking animal in the sale order. Sheep breed champions will sell after the Grand and Reserve Grand lambs in quality order selected by the sheep judge.
- 10. The Payne County Premium Sale Committee will award the <u>Jordan Morris Memorial Trophy</u> to the Premium Sale Market Steer Exhibitor in grade 9-12 with the highest GPA. Any ties in GPA are decided by the highest rank in the sale order. A \$500 Scholarship will accompany this award. Recipient must show 2.5 or higher GPA, or equivalent in first semester post high school and enrollment into next semester. Exhibitors are only able to receive this award once during their junior show career. This scholarship is sponsored by Absolute Bovine Genetics.
- 11. The Premium Sale Committee will interpret all Premium Sale rules, and their decisions will be final.
- 12. <u>Note:</u> No animals will be sold. Only the premium on the animals will be sold.

All teams must consist of two team members. Each team must have at least one member under the age of 15 on the day of the OYE contest. The top two teams will be able to advance to OYE if youth are exhibiting livestock at OYE. Let Summer Leister know by Thursday February 26, 2026, if you plan to advance, so she can get you entered for OYE.

#### Check In:

All teams must attend a mandatory meeting at 5:30 pm Saturday, February 21, 2026, in the show ring.

#### Judging:

Will be at 6 pm Saturday, February 21, 2026.

#### **Special Rules:**

- 1. The contest time will be 30 minutes in length. A 10-minute warning will be given. At the end of the 30-minute allotted time, clippers down and work stopped.

If youth are exhibiting livestock at OYE, let Summer Leister know by Thursday, February 26, 2026, if you plan to advance, so she can get you entered for OYE.

#### Check In:

All teams must attend a mandatory meeting at 1:30 pm, Tuesday, February 24, 2026, in the arena.

#### Judging:

Will be 2:00 pm Tuesday, February 24, 2026, in the arena.

#### **SPECIAL RULES**

- 1. Contest time will be 30 minutes in length. A ten-minute warning will be given. At the end of the 30-minute allotted time, clippers down and work stops.
- 2. All grooming rules of the OK Youth Expo will be strictly enforced.

- Beef superintendents reserve the right to divide breed classes by weight or by numbers into two classes when there are 8 or more. If there are 18 or more, steers of one breed, there may be 3 classes. If there are 41 or more there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.
- 2. Refer to General Rules 1 & 18.
- The Beef Show will be blow and show. The use of paint, glue, foam, or other adhesives and boning products of any kind will not be permitted. Boning of legs, alteration, or enhancement of color will not be allowed. Water, light oils, or sheen type products will be allowed. In short, if you question whether or not a product is allowed, do not use it. No aerosol cans, spray bottles, or styling products other than combs will be allowed past the checking area. Any cattle found in violation will not be allowed in the show ring and will be disqualified from the competition and award premium opportunities. All beef superintendents' decisions will be FINAL!
- 4. All prospect steers must have been nominated at the official county nomination held in January 2026 to prove ownership. Prospect Steers: Exhibitors must have had continuous ownership of and personally fed and cared for daily. Prospect steers 1000 lbs. or less by the due date of county nominations/entry.

## **SECTION 2 – MARKET STEERS**

**SHOW ORDER:** Classes will be shown in alphabetical order with AOB showing last or by weight, as determined by beef superintendent

- Steers must be in place by 6:00 pm, Tuesday, Feb. 24
- Steers will be weighed at 6:30 pm Tuesday, Feb. 24 by beef superintendents.
- 1. All market steers must have been owned 90 days prior to opening day of the county show. Refer to General Rules 1 & 18.
  - 2. Beef superintendents reserve the right to divide breed classes by weight or by numbers into two classes when there are 8 or more. If there are 18 or more of one breed, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.
- 3. All market steers weighing 1001 lbs or more must have OYE or county ear tag in ears to be eligible to be shown. If any steer has lost his tag, prior arrangement with OYE and/or county nomination committee must be made prior to show. Superintendent reserves the right to take all measures necessary to assure identification of the calf in question. Exhibitors must have had continuous ownership of and personally fed and cared for daily. Market steers weighing 1001 lbs. or more, by the due date of county nominations/entry.
- 4. The Beef Show will be blow and show. The use of paint, glue, foam, or other adhesives and boning products of any kind will not be permitted. Boning of legs, alteration, or enhancement of color will not be allowed. Water, light oils, or sheen type products will be allowed. In short, if you question whether or not a product is allowed, do not use it. No aerosol cans, spray bottles, or styling products other than combs will be allowed past the checking area. Any cattle found in violation will not be

allowed in the show ring and will be disqualified from the competition and award premium opportunities. All beef superintendents' decisions will be FINAL!

### 5. <u>Jordan Morris Memorial Trophy and Scholarship Award</u>

Steer exhibitors who wish to apply for the Jordan Morris Memorial Trophy and \$500 Scholarship must submit a completed form and official transcript to DeeDee in the main office by 3pm Wednesday afternoon the week of the Spring Show.

## **SECTION 3 – BEEF HEIFER**

**SHOW ORDER:** Breeds will be shown in alphabetical order, with AOB showing last.

- Heifers must be in place by 6:00 p.m. Tuesday, Feb. 24
   Heifers will be checked in at 6:30 p.m. Tuesday, Feb. 24
- 1. Registration papers or proof of registration must be presented to the superintendent. Heifers must be registered in the name of the exhibitor as sole owner for a period of continuous ownership of 45 days or more prior to opening date of show. Any heifer that has been exhibited in the name of a partnership within 45 days of the date of the county show is subject to disqualification if confirmation from breed association proves multiple ownership. Refer to General Rules 1 & 18.

Commercial heifers must be in junior exhibitor's possession 45 days prior to county show. The exhibitor will be required to bring an affidavit from the Ag Teacher or 4-H Leader indicating the ownership date to the check-in at the show.

2. The Beef Show will be blow and show. The use of paint, glue, foam, or other adhesives and boning products of any kind will not be permitted. Boning of legs, alteration, or enhancement of color will not be allowed. Water, light oils, or sheen type products will be allowed. In short, if you question whether or not a product is allowed, do not use it. No aerosol cans, spray bottles, or styling products other than combs will be allowed past the checking area. Any cattle found in violation will not be allowed in the show ring and will be disqualified from the competition and award premium opportunities. All beef superintendents' decisions will be FINAL!

- 3. Each exhibitor may exhibit 2 heifers per class.
- 4. Animals must be permanently tattooed according to breed specifications.
- 5. Heifers in classes #8 and #9 must have a certificate from a veterinarian stating that the heifer is pregnant or must be nursing her calf. All heifers born January 1, 2024, or later are eligible to be shown.
- 6. All commercial heifers will show in classes as "broken up" by hip height as measured at check-in.

**SHOW ORDER:** Ayrshire, Brown Swiss, Guernsey, Holstein, Jersey, Milking Shorthorn, AOB, and Commercial will show last.

- Dairy heifers must be in place by 6:00 p.m. Tuesday, Feb. 24
   Dairy heifers will be verified at 6:30 p.m. Tuesday, Feb. 24
   by dairy superintendents.
- 1. Registration papers or proof of nominations must be presented to the superintendent. Must be registered/nominated in the name of the exhibitor for a period of continuous ownership or transfer of ownership 75 days or more before opening date of show. Refer to General Rules 1& 18
- 2. Each exhibitor may exhibit 2 heifers per class.
- 3. Animals must be permanently identified according to breed specifications.
- 4. Because apparel requirements are predetermined for junior dairy exhibitors, they will be required to wear the 4-H or FFA emblem when showing in their respective competitions. Exhibitors must adhere to the dress code to be allowed in the show ring.
- 5. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show.

#### 6. Classification of Breeds: NO PHOTOCOPIED PAPERS ALLOWED

#### Aryshire

All animals exhibiting in the International Ayrshire Show must be verified as at least 87% Ayrshire by the U.S. Ayrshire Breeders' Association.

#### **Brown Swiss**

Animals eligible to be shown at the International Brown Swiss show will have the following registration certificates. Standard Registration Certificate, which is white with a green border is issued for Registered Brown Swiss Females and Identity Enrolled Females (CIE) (93.75%). Brown Swiss Step II Identity Enrollment (IE) (87.50%) animals that have a green registration paper with black border may also be shown. Animals with other colored papers cannot be shown.

#### Guernsey

Animals must be registered in the Herd Register of the American Guernsey Association (i.e., have a GR status.)

### <u>Holstein</u>

Animals with 87% Registered Holstein Ancestry (RHA) and above are eligible to show.

### <u>Jersey</u>

Animals must be registered in the Herd Register of the American Jersey Cattle Association (i.e., have GR status.)

### Milking Shorthorn

Eligibility: All yellow registration papers and all white background papers stamped "Not Eligible to Show" will not be allowed to be exhibited as a registered Milking Shorthorn. Milking Shorthorns must have an EXP Status to show.

# **SECTION 5 – MARKET SHEEP**

### SHOW ORDER: Market Sheep

Dorset; Hampshire; Natural; AOB/Speckle Face; Shropshire;

Southdown; Suffolk; Crossbred

- 1. All Sheep must be in place by 6:30 pm Monday, February 23 weighing of lambs will start at 7:00 pm Monday, February 23
- Wether or ewe lambs can be shown and must have been nominated for OYE or county only to be eligible to be shown. Sheep will show according to breed as determined at OYE or County only nomination. Breed classification is subject to change at the discretion of sheep superintendents at the time of weighin for the show.
- 3. Sheep superintendents reserve the right to divide classes by weight or by numbers when there are six or more animals per breed. If there are 18 or more per breed, there may be 3 classes. If there are 41 or more per breed, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.
- 4. The minimum weight for lambs will be 75 lbs.
- 5. All lambs MUST HAVE Scrapies tags in their ear. All lambs MUST HAVE an ear tag to identify them. Scrapies tags in the ears will work for their identification tag.

- 6. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show. In sheep, no paint, belly wool, or live fungus is allowed. If found, exhibitors and animals will be disqualified.

## **BREEDING EWES**

### SHOW ORDER: Registered Ewes -

Dorset; Dorset Advantage; Hampshire; Shropshire; Southdown; Suffolk; AOB

- 1. All Sheep must be in place by 6:30 pm Monday, February 23 weighing of lambs will start at 7:00 pm Monday, February 23
- 2. All lambs MUST HAVE scrapies tags in their ear. All lambs MUST HAVE an ear tag to identify them.
- 3. Class will be broken by weight.
- 4. Every animal entered as a Purebred (registered) Ewe must have a registration paper issued by the respective breed association. The ewe must be registered in the name of the junior exhibitor prior to January 1, of the current year. No partnership is allowed. Exhibitors must maintain continuous ownership, possession and provide daily care for each Breeding Ewe entered in the show.
- 5. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show. In sheep, no paint, belly wool, or live fungus is allowed. If found, exhibitors and animals will be disqualified.

# **SECTION 6 – GOATS**

**SHOW ORDER:** Breeding Does/Wethers-Light to Heavy

- 1. All goats must be in place by 3:30 p.m. Saturday, February 21, weighing of goats will start at 4:00 pm Saturday, February 21
- 2. Goats must be dehorned or have horns tipped; they must be blunt. Wethers must be completely healed from castration (No bucks allowed).
- 3. The minimum weight for wethers goats will be 40 pounds with no maximum weight. The maximum weight limit for does will be 160 pounds.
- 4. Goat superintendents reserve the right to divide classes as they deem necessary. The Numbers of the Division Champions are at the discretion of the superintendent.
- 5. All goats MUST HAVE scrapies tags in their ear. All goats MUST HAVE an ear tag to identify them. Scrapies tags in the ears will work for their identification tag.
- 6. Goats with "Live Fungus" will be disqualified, see general rule 8
- 7. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show. In goat, no glue products will be allowed in the fitting of goats, but powder is allowed. Blow and Show ONLY.

- 8. Refer to General Rules 1 & 18.
- 9. Bracing is allowed on wethers only. All four feet must be on the ground when being evaluated by the judge.
- 10. Does and wethers will be shown separately, and classes will be divided by weight.

# **SECTION 7 – SWINE**

#### SHOW ORDER for Breeding Gilts:

Berkshire, Chester White, Duroc, Hampshire, <u>Herefords, Landrace</u>, Poland China, Spots, Yorkshire, <u>Light</u> Crossbred, <u>Dark Crossbred</u>

#### SHOW ORDER for Market Barrows:

Berkshire, Chester White, Duroc, Hampshire, <u>Herefords</u>, Poland China, Spots, Yorkshire, <u>AOB (if necessary)</u>, Crossbred

\*All swine characteristic guidelines will be followed by National Swine Registry and Certified Pedigree Swine\*

All <u>swine MUST NOT BE UNLOADED</u> until checked by <u>superintendents</u>. If you are not checked in by the <u>superintendent</u> at the check point location and times, you <u>WILL NOT</u> be allowed to show at this year's Jr. Livestock Show.

- 1. Swine must be checked in by superintendents only during the following time:
  - Sunday, February 22, 10:00 am 3:00 pm
  - Swine will be weighed on Sunday, February 22, 4:00pm
  - After the market barrows and crossbred gilts are weighed in, then the Purebred Gilt papers will be checked.
- 2. All market <u>barrow</u> swine must weigh 200 280 lbs. Those who do not making weight will <u>not be allowed to show.</u>
- 3. All purebred breeding gilts must be registered with their respective breed associations. An exhibitor may exhibit an animal registered in the name of a fellow exhibitor as described in the household nomination.

  Swine exhibitors must have all gilts by nomination/entry and pedigree registration sale date must be prior to the nomination/entry date.

- Pedigrees/Registration papers will be checked in prior to show according to swine superintendent.
   NOTE: Pedigrees/Registration papers that are simply signed on the back by the respective breeder and not officially transferred into the exhibitor's name by the breed association will not be accepted and gilts must be shown in the commercial gilt division.
- 5. <u>All Commercial gilts must weigh 200-340 lbs. Those</u> not making weight will not be allowed to show.
- 6. All purebred breeding gilts will be shown by age.
  Purebred breeding gilts born between July 1 and
  October 31 are eligible to show.
- 7. Each exhibitor is permitted to show not more than 3 market <u>barrows and 3 total gilts (purebred & commercial combined).</u>
- 8. Gilt must be shown in the gilt show, and barrows must be shown in the barrow show.
- 9. All exhibitors shall abide by the stall assignments made and posted on the grounds. Superintendents of each species shall have the authority to supersede the posted stall assignments at their own discretion, or as circumstances require. Failure to abide by stall assignments and/or instructions of Show Superintendents shall result in the exhibitor forfeiting all rights to participate in the show.
- 10. Refer to General Rules 1 & 18.

- 11. All exhibitors are expected to provide the primary care and grooming of their animals throughout the show. An exhibitor may be assisted in grooming his/her animal. However, the exhibitor must be present and apply the level of expertise appropriate for that exhibitor's level of experience as deemed by his/her Ag Ed Instructor or county 4-H Agent. Therefore, beginning showmen are allowed more assistance than seasoned showmen.
- 12. No alteration or simulation with respect to color of hair will be permitted on any junior animals. This includes all products, natural or man-made; false switches are permitted. If alteration or addition is detected by a show official or through a protest, the exhibitor, organized group, or individual involved will be disqualified and barred from exhibiting. These grooming rules apply to both sexes, all species, for the duration of the junior division of the show.

  In swine, no powdering, oiling, painting, or dressing other than
  - In swine, no powdering, oiling, painting, or dressing other than water will be permitted.
- 13. Parents and/or grooms' people will refrain from grooming animals as they enter the show ring. Superintendents will prohibit parents and grooms' people from the show ring, holding area entrances.
- 14. For Swine <u>Barrows</u>, the <u>eight</u> pure breeds to be recognized as a breed, they must have at least <u>4 in that breed to be</u> shown. If not, those animals will be shown <u>in AOB class</u>. As long as there are at least <u>4 head in the AOB class</u>, the champion will sell in the Premium Sale. If AOB class doesn't meet classifications to make a breed, then AOB will fall under Class <u>1 of Crossbreds</u>, as Class <u>1 AOB/Cross</u>. For Swine Gilts, all nine purebred breeds will be allowed to be shown as their registered breed.

- 15. Swine superintendents reserve the right to divide classes by weight or by numbers when there are six or more animals perbreed. If there are 18 or more per breed, there may be 3 classes. If there are 41 or more per breed, there may be 4 classes. Superintendents have the discretion to adjust the number of classes due to weight variation within the breeds.
- 16. Entries must not be removed before the closing of the show except by consent of the superintendent.
- 17. All market barrows will be shown according to breed classifications. It is at the superintendent's discretion if a classification needs to be changed.
- 18. To be shown in a purebred gilt class, all swine must have registration papers in exhibitors' names. If no registration papers, then those gilts will be shown as a crossbred.

### 19. Light Cross Gilt Color:

- 1. Any gilt with white and/or blue only.
- 2. Classification will be conducted by a three-member classifying committee. The decision of the classifying committee is final and not subject to protest.

### Dark Cross Gilt Color:

- 1. All other colors, (black, red, and sandy), excluding solid white or blue.
- 20. Pens must be bedded with wood shavings before putting animals in stalls/pens.

- 21. The State Department of Agriculture requires evidence of a negative pseudo rabies virus (PRV) test (test chart) for all shows. This chart must be presented prior to unloading. All swine must have a premise ID number entered for the county show to review. The following steps are required to exhibit market swine (barrows & gilts) inOklahoma spring shows: Have a negative pseudo rabies test conducted after November 10, 2025, and is identified on the test chart by official identification number, to be individually identified withan official identification device permanently affixed to the ear (Plastic ear tag is recommended) present test record at each exhibition.
- 22. After exhibiting, market swine must be kept separate and apart from all breeding swine or until they are retested negative in not less than 30 days following last exhibition or shipped directly to slaughter. Ear tags and test papers must be checked before unloading.
- 23. All swine exhibitors are allowed to show in the showmanship contest. At the appropriate time for the showmanship contest to begin, the superintendent shall call the first age group to begin making their way to the show ring. The first ten exhibitors entering the holding area will then comprise the first 'heat' for that age group. The judge will evaluate those exhibitors and select the one or ones that he wishes to retain for the final heat. When the judge concludes the first heat then the next ten exhibitors entering the holding area will comprise the second heat. This process will be repeated until all that wish to show in their division have entered the ring. Then the judge will bring back the exhibitors that were retained for the final heat, evaluate them, speak to them if he wishes, and select the top five and a champion.

Gilts or Barrows may be shown in showmanship.

24. Family nominations will be specified at the time you weigh in at the scales. All Information, exhibitor, club/chapter, breed, tag, etc. must be correct on an official printed card, no hand-written changes can be made, except by swine superintendents. Exhibitors may change their swine classification from a purebred to a Crossbred Only prior to weighing.

**NO CHANGES** will be allowed after the cards are turned into superintendent at the scales.

25. Only one person per community is allowed in swine holding area this person will be designated by that community's ag teacher.

## **SECTION 8 – MARKET BROILERS**

- Broilers will be checked in the coop area at 10:00 a.m.
   Wednesday, Feb. 25.
- Broilers must be in place by 11:00 a.m Wednesday Feb. 25.
- Broiler Judging begins at 1:00 p.m. Wednesday Feb. 25.

#### No substitutions are allowed.

Only one pen per exhibitor may be entered. One pen of three birds-ONLY birds purchased from The Payne County Expo Center Office/Payne County Jr. Livestock Show for the 2026 Payne County Jr Livestock Show are eligible to compete.

- 1. All chicks will be wing banded. No broiler will be accepted for show at the Payne County Jr Livestock Show without the original wing band still in place.
- 2. The owner/exhibitor is the person who ordered the birds. The broilers, from the time of delivery, must have been fed and cared for daily by the exhibitor. Birds will be the responsibility of the exhibitor, from check- in time to check- out time. Each exhibitor must provide all feed, water, dispensers, fans, ice, etc. All handling of birds after checking in is prohibited except as directed by the poultry superintendent.
- 3. Coop of broilers will be sifted at check in. All entries must be US Grade A live market quality, to be accepted. A pen may be sifted for the lack of uniformity. Each broiler must have a wing band in place. Any broiler, which has no wing band, regardless of the reason will be sifted. After the broilers have been officially cooped, they may not be handled by anyone except the judge and the youth handlers until all judging has been completed.

- 4. Judging will be made according to US standards for live chickens. Placing will be made based on market quality. Showing will require the youth exhibitor plus one or two other handlers, preferably another youth. Non-youth handlers may be allowed if prior approval is obtained from the show superintendent. Youth shall follow the Payne County Jr Livestock Show Rules for appropriate dress.
- 5. All entries will be subject to the health and safety regulations of the Payne County Jr Livestock Show with the exception of Pullorum Typhoid testing and health certificates. All Jr Market broilers originated from a certified NPIP Flock and are under 6 months of age; therefore, Pullorum testing, and health certificates are not required by the Oklahoma Department of Agriculture, Food and Forestry.
- 6. Sick and/or diseased birds will not be accepted and if discovered during the show, will be removed from competition. Any bird with reduced comb growth or other secondary sex characteristics, which indicate the presence of a hormone, will be sifted. Sifted birds must be removed from the Payne County Expo Center immediately by the exhibitor. Payne County Jr Livestock Show assumes no responsibility for the birds.
- 7. Exhibitors shall follow the rules and regulations of the Payne County Jr Livestock Show.
